#### **G504 Dual DPDT Foot Switch**

The G504 Dual DPDT foot switch is ideal for controlling up to four independent circuits, or for switching the circuits operating on different voltages. Each circuit has SPDT contacts (can be wired normally open or normally closed). Each side can be independently adjusted so two switches activate at the same time or at separate times as the pedal is pressed down.

### **Design features:**

- Ideal for controlling up to four independent circuits.
- Consists of two switches, each with DPDT circuitry.
- Each circuit is rated 10 amps @ 125/250 VAC.
- Can be set so both switches go off at the same time, or so the first two activate before the second two.
- 3/4"-14 N.P.T. threaded conduit entry.
- Standard G-Series features including oversized guard and rugged construction that will not break when dropped.



G-Series Installation / Adjustment / Maintenance

## **G-Series Installation Instructions**

Only a qualified electrician should install this foot switch, including proper grounding and installation per local and national electrical codes. The G-Series foot switches are to be installed using a Type 2, 4, and 13 cord grip and UL Listed hard-service or junior hard-service flexible cord suitable for resisting oil and water. Cover screws should be installed using 18-22 in-lb. torque after wiring is installed.



## **G-Series Switch Adjustment**

**Danger:** Disconnect input power before performing any installation or maintenance.

Some G-Series foot switches have an adjustable switch activation point. These switches will have the adjustment screw as shown in the diagram.

To increase travel before the switch is activated, turn the Adjustment Screw clockwise. To decrease travel before the switch is activated, turn the Adjustment Screw counter-clockwise.



## Periodic Maintenance for -MA and -AT Models

Every 6 months or 50,000 cycles, apply a strip of grease to the contact surface between the latches and the pedal lever for Maintained and Anti-Trip ("-MA" and "-AT") models. Periodic lubrication of exterior springs using a light oil is also recommended. Check to make sure the product and all parts function properly. Discard and replace any defective product immediately.
